Professional Certification

The NACCTFO Certification Program provides County Finance Officials the opportunity to:

- Achieve national education certification recognition
- Maintain high educational standards

Certification Levels

- Government Finance Officer - 21 hours
- Finance Executive - 60 hours
- Finance Professional - 84 hours
- Finance Master - 100 hours
- Re-Certification Award—50 hours increments above Finance Master

Administration of the Certification Program:

NACCTFO has contracted with the Wayne State University Public Administration Program to facilitate our national education certification program.
